

GYM AND STUDIO FITNESS + SWIMMING POOL MEMBERSHIP

Apply from 25.03.2024 r.

1. The "Premium Gym and Fitness Studio + Swimming Pool" pass allows access to the Gym, Fitness Studio, and Swimming Pool at the Przystań Sports and Recreation Center on Eisenberga Street.
2. The pass is available in the following configurations:
 - 2.1. **Premium Gym and Fitness Studio + Swimming Pool (30 days)**, which entitles the holder to:
 - a) Access to the Swimming Pool once daily for a period of 30 days, with no time restrictions.
 - b) Unlimited access to the Gym for 30 days, with no time restrictions.
 - c) Participation in Fitness Studio classes for 30 days.
 - 2.2. **Premium Gym and Fitness Studio + Swimming Pool (90 days)**, which entitles the holder to:
 - a) Access to the Swimming Pool once daily for a period of 90 days, with no time restrictions.
 - b) Unlimited access to the Gym for 90 days, with no time restrictions.
 - c) Participation in Fitness Studio classes for 90 days.
3. Purchasing the pass requires prior purchase of a dedicated pass card.
4. The cost of the pass card is PLN 22.00 (twenty-two zlotys). This is a one-time, non-refundable fee, payable at the time of pass purchase.
5. The "Premium Gym and Fitness Studio + Swimming Pool" pass is available to adults with full legal capacity.
6. The pass is non-transferable and can only be used by the person named on the pass.
7. Each time the pass is used, a valid photo ID must be presented at the reception desk.
8. The pass can be used during the operating hours of the respective zones at the Przystań on Eisenberga facility for the duration of its validity.
9. The pass is valid for 30 days or 90 days from the date of purchase.
10. The pass cannot be exchanged for cash.
11. The pass is issued for a fixed term of 30 or 90 days. After this period, the pass expires.
12. The **30-day Premium pass** can be suspended once during its validity for a non-refundable fee of PLN 30, for a period no shorter than 7 days and no longer than 14 days. Suspension requests must be submitted via email to bok@przystannaeseisenberga.pl.
13. The **90-day Premium pass** can be suspended twice during its validity, free of charge, for periods no shorter than 7 days and no longer than 14 days. Suspension requests must be submitted via email to bok@przystannaeseisenberga.pl.
14. The pass can be recharged, extending its validity, according to the applicable price list. Unused Swimming Pool minutes cannot be transferred to a new or recharged pass.
15. In the event of loss, damage, or destruction of the pass, unused funds on the pass are non-refundable. A replacement card can be issued after a non-refundable fee of PLN 22.00 that can be paid at the reception desk.
16. The Przystań Sports and Recreation Center reserves the right to limit the number of available passes and suspend further sales if necessary.
17. If the passholder recharges the pass within 14 days of its expiration, they will be exempt from the PLN 22.00 activation fee.
18. If the pass is not recharged within 14 days of expiration, the activation fee of PLN 22.00 must be paid upon purchasing a new pass.
19. Any interruption in the pass validity of more than 14 days will require the payment of the PLN 22.00 activation fee.
20. In the event of unforeseen circumstances (force majeure), the pass may be frozen until the situation is resolved, and its validity will be extended for the same period. Force majeure is defined as events beyond the control of the Przystań Sports and Recreation Center, which disrupt or prevent the use of the pass.
21. Purchasing the pass signifies acceptance of these regulations. These regulations apply to all holders of the "Premium Gym and Fitness Studio + Swimming Pool" pass.
22. Any amendments to these regulations must be made in writing and communicated to customers via the website and posted in a public area.
23. In the event of changes to the regulations, the customer may terminate the agreement at the end of the pass's validity period by submitting a written or emailed declaration of intent, citing the changes as the reason for termination.
24. Customers have 14 days to submit their termination declaration following the announcement of regulation changes. After this period, it is assumed that the customer accepts the changes.
25. Przystań on Eisenberga reserves the right to change the price list and the scope of services offered. These changes do not constitute amendments to the agreement or the regulations.
