

GYM AND STUDIO FITNESS + SAUNA MEMBERSHIP

Apply from 25.03.2024 r.

1. The "Gym and Fitness Studio + Saunarium" pass grants access to the Gym and Fitness Studio areas, as well as the Saunarium area at the Przystań Sports and Recreation Center on Eisenberga Street.
2. The pass is available in the following configuration:
 - 2.1. Gym and Fitness Studio + Saunarium 30 days, which entitles the holder to:
 - a) Unlimited access to the Gym for a period of 30 days, without time restrictions.
 - b) Participation in Fitness Studio classes for 30 days.
 - c) Access to the Club Sauna for 30 days during its operating hours.
 - d) Use of 360 minutes (6 hours) in the Saunarium area over the 30-day period (time is calculated to the minute).
3. Purchasing a pass requires the prior purchase of a dedicated pass card.
4. The cost of the pass card is PLN 22.00 (twenty-two zloty). This is a one-time, non-refundable fee, payable upon the purchase of the pass.
5. The "Gym and Fitness Studio + Saunarium" pass is available only to individuals who are of legal age and have full legal capacity.
6. The pass is non-transferable and can only be used by the person whose name appears on the pass.
7. Each time the pass is used, a valid photo ID must be presented at the reception desk.
8. The pass can be used during the operating hours of the Gym area for the duration of its validity.
9. The pass is valid for either 30 days or 90 days, starting from the date of purchase.
10. The value of the pass is non-redeemable for cash.
11. The pass is issued for a fixed term: either 30 or 90 days. After this period, the pass expires.
12. The Standard Gym and Fitness Studio pass for 30 days may be suspended at any time once during its validity for a fee of PLN 30, for a period no shorter than 7 days and no longer than 14 days. The suspension must be requested via email to bok@przystannaeseisenberga.pl, and the suspension fee is non-refundable.
13. The pass can be recharged, extending its validity period in accordance with the applicable price list. Unused Saunarium minutes cannot be transferred to a newly purchased or recharged pass.
14. In case of loss, damage, or destruction of the pass, the unused resource is non-refundable. The issuance of a new card will require a fee of PLN 22.00 (twenty-two zloty) to cover the costs of replacement.
15. The Przystań Sports and Recreation Center reserves the right to limit the number of available passes and to suspend further sales.
16. If the customer recharges their pass within 14 days of its expiration, the activation fee of PLN 22.00 will be waived.
17. If the pass is not recharged within 14 days of expiration, the customer will be required to pay the activation fee of PLN 22.00 upon purchasing a new pass.
18. Any interruption in the pass validity of more than 14 days will require the payment of the PLN 22.00 activation fee.
19. In cases where the passholder is unable to use the service due to force majeure, the pass may be frozen until the situation is resolved, with the pass validity extended for the same duration as the freeze.
20. Purchasing the pass signifies agreement with these regulations. These regulations apply to all holders of the "Gym and Fitness Studio + Saunarium" pass.
21. Any amendments to these regulations require written form and must be communicated to customers via the website and posted in a public area.
22. In the event of regulation changes, the customer may terminate the contract at the end of the pass's validity period by submitting a written or email declaration of intent, specifying the regulation change as the reason for termination.
23. The customer has 14 days to submit a declaration of intent to terminate the contract following the announcement of regulation changes. After this period, it is assumed that the customer accepts the changes.
24. Przystań on Eisenberg reserves the right to change the price list and the range of services offered. These changes do not constitute an amendment to the agreement or the regulations.
