

GYM AND STUDIO FITNESS MEMBERSHIP

Apply from 25.03.2024 r.

1. The Standard Gym and Fitness Studio Membership allows access to the Gym and Fitness Studio at the Przystań na Eisenberga Sports and Recreation Center.
2. The membership is available in the following configuration: 2.1 **Standard Gym and Fitness Studio Membership - 30 days**, which entitles the holder to:
 - a) Unlimited access to the Gym for 30 days, with no time restrictions.
 - b) Participation in Fitness Studio classes for 30 days.
 - c) Access to the Club Sauna for 30 days during its operating hours.2.2 **Standard Gym and Fitness Studio Membership - 90 days**, which entitles the holder to:
 - a) Unlimited access to the Gym for 90 days, with no time restrictions.
 - b) Participation in Fitness Studio classes for 90 days.
 - c) Access to the Club Sauna for 90 days during its operating hours.
3. The purchase of the membership requires the prior purchase of a dedicated membership card.
4. The cost of the membership card is 22.00 PLN (twenty-two zloty). This is a one-time, non-refundable fee that must be paid at the time of membership purchase.
5. The Standard Gym and Fitness Studio Membership can only be held by an adult with full legal capacity.
6. The Standard Gym and Fitness Studio Membership is personalized and can only be used by the person whose name is on the membership card.
7. Each time the membership is used, the holder must present a valid photo ID at the reception.
8. The membership can be used during the operating hours of the Gym area within the period of validity.
9. The membership is valid for 30 or 90 days from the date of purchase.
10. The value of the membership cannot be exchanged for cash.
11. The membership is issued for a fixed term: 30 days or 90 days. After this period, the membership expires.
12. The **Standard Gym and Fitness Studio Membership - 30 days** can be suspended once during its validity period for a fee of 30 PLN, for a minimum of 7 days and a maximum of 14 days. The suspension request must be submitted via email to bok@przystannaeseisenberga.pl. The non-refundable fee must be paid according to the current pricing as a condition for suspension.
13. The **Standard Gym and Fitness Studio Membership - 90 days** can be suspended free of charge up to twice during its validity period for a minimum of 7 days and a maximum of 14 days each. The suspension request must be submitted via email to bok@przystannaeseisenberga.pl.
14. The membership can be renewed, which will extend its validity according to the current Pricing. The membership must be presented in a condition that ensures its continued use. Prices, value, minute allowances, and validity are outlined in the current Pricing.
15. In the event of loss, damage, or destruction of the membership card that prevents further use, unused funds on the card will not be refunded. Any such incidents must be reported immediately to authorized personnel at the Przystań na Eisenberga Center. A new card can be issued for a non-refundable fee of 22.00 PLN (twenty-two zloty).
16. Przystań na Eisenberga Sports and Recreation Center reserves the right to limit the number of memberships sold and to suspend further sales to maintain service quality.
17. If the customer renews the membership within 14 days of its expiration by purchasing a new membership according to the Pricing, they will be exempt from the 22.00 PLN activation fee.
18. If the customer does not renew the membership within 14 days of its expiration, they will be required to pay the 22.00 PLN activation fee and purchase a new membership in accordance with the Przystań na Eisenberga Pricing.
19. Any lapse in membership continuity beyond 14 days will require payment of the 22.00 PLN activation fee.
20. If the membership holder is unable to use the service due to unforeseen circumstances (Force Majeure), the membership may be frozen until the situation is resolved, extending the membership duration by the period of the freeze. Force Majeure is understood as events beyond the control of Przystań na Eisenberga that cannot be anticipated and that disrupt or prevent the use of the membership.
21. The purchase of a membership signifies that the customer has read and accepted these Terms and Conditions. These terms apply to all holders of Standard Gym and Fitness Studio Memberships. Purchasing a membership indicates acceptance of all regulations in force at the facility.
22. Any changes to these terms must be made in writing and communicated to customers via the website and in publicly accessible areas.

23. In the event of a change in the regulations, the customer has the right to terminate the agreement at the end of the membership period by submitting a written or email notice stating that the change in terms is the reason for termination.
24. The deadline for submitting a notice of termination is 14 days from the time the change is announced. If no notice is submitted within this period, it is assumed that the customer accepts the changes.
25. Przystań na Eisenberga reserves the right to change pricing and the range of services provided. Such changes do not constitute a change to the agreement or these Terms and Conditions.
