

SAUNA + SWIMMING POOL MEMBERSHIP

Apply from 25.03.2024 r.

1. The **Premium Saunarium + Swimming Pool** pass grants access to both the Swimming Pool and Saunarium at the Przystań Sports and Recreation Center on Eisenberga Street.
2. The pass is available in the following configurations:
 - 2.1 **Premium Saunarium (360 minutes/6 hours) + Swimming Pool**, which entitles the holder to:
 - a) Access to the Swimming Pool once daily for a period of 30 days, with no time restrictions.
 - b) Use of 360 minutes (6 hours) in the Saunarium within 30 days, calculated to the minute.
 - 2.2 **Premium Saunarium (600 minutes/10 hours) + Swimming Pool**, which entitles the holder to:
 - a) Access to the Swimming Pool once daily for a period of 30 days, with no time restrictions.
 - b) Use of 600 minutes (10 hours) in the Saunarium within 30 days, calculated to the minute.
3. Purchasing the pass requires prior acquisition of a dedicated pass card.
4. The cost of the pass card is PLN 22.00 (twenty-two zlotys). This is a one-time, non-refundable fee payable at the time of pass purchase.
5. The **Premium Saunarium + Swimming Pool** pass is available for adults with full legal capacity.
6. The pass is non-transferable and can only be used by the individual whose name is on the pass.
7. A valid photo ID must be presented at the reception desk each time the pass is used.
8. The pass can be used during the operating hours of the respective zones at the Przystań on Eisenberga facility for the duration of its validity.
9. The pass is valid for 30 days from the date of purchase.
10. The pass value cannot be exchanged for cash.
11. The pass is issued for a fixed period of 30 days. After this period, the pass expires.
12. The **30-day Premium Saunarium + Swimming Pool pass** can be suspended once during its validity for a non-refundable fee of PLN 30, for a period no shorter than 7 days and no longer than 14 days. Suspension requests must be submitted via email to bok@przystannaeseisenberga.pl.
13. The pass can be recharged to extend its validity according to the current price list, provided the pass is in a condition that guarantees its continued use. Unused Saunarium minutes cannot be transferred to a new or recharged pass.
14. In the event of loss, damage, or destruction of the pass, unused funds on the pass are non-refundable. A replacement card can be issued after a non-refundable fee of PLN 22.00 is paid at the reception desk.
15. The Przystań Sports and Recreation Center reserves the right to limit the number of passes available and to suspend further sales to ensure service quality.
16. If the pass is recharged within 14 days of its expiration, the customer will be exempt from the PLN 22.00 activation fee.
17. If the pass is not recharged within 14 days of expiration, the customer must pay the PLN 22.00 activation fee and purchase a new pass in accordance with the current price list.
18. Any interruption in the pass validity of more than 14 days will require payment of the PLN 22.00 activation fee.
19. In case of force majeure, which prevents the passholder from using the service at the same level, the pass may be frozen until the situation is resolved, extending the pass validity for the same period during which the service was unavailable. Force majeure is defined as events beyond the control of the Przystań Sports and Recreation Center that disrupt or prevent the use of the pass.
20. Purchasing the pass implies the acceptance of these regulations. These regulations apply to all holders of the **Premium Saunarium + Swimming Pool** pass. Purchasing the pass implies acceptance of all the rules in force at the Przystań on Eisenberga facility.
21. Any changes to these regulations must be made in writing and communicated to customers via the website and in public areas.
22. In case of changes to the regulations, the customer may terminate the agreement at the end of the pass validity period by submitting a written or emailed declaration of intent, citing the regulation changes as the reason for termination.
23. The customer has 14 days to submit a termination declaration after the announcement of regulation changes. After this period, it is assumed that the customer accepts the changes.
24. Przystań on Eisenberga reserves the right to change the price list and scope of services. These changes do not constitute amendments to the agreement or the regulations.
