

VIP MEMBERSHIP

Apply from 25.03.2024 r.

1. The VIP Membership Card allows access to the Gym, Fitness Studio, Swimming Pool, and Sauna areas at the Przystań na Eisenberga Sports and Recreation Center.
2. The VIP Membership entitles the holder to:
 - a) Use the Swimming Pool once per day for 30 days, with no time restrictions.
 - b) Unlimited daily access to the Gym for 30 days, with no time restrictions.
 - c) Participation in Fitness Studio classes for 30 days.
 - d) 600 minutes (10 hours) of access to the Sauna area over 30 days, calculated per minute.
3. The membership is sold with a specific number of sauna minutes in accordance with the current Price List of Przystań na Eisenberga. After exploiting the sauna minutes during the membership period, an additional fee will apply according to the Price List.
4. Purchasing a membership requires prior purchase of a dedicated membership card.
5. The cost of the membership card is 22.00 PLN (in words: twenty-two PLN). This is a one-time, non-refundable fee that must be paid at the time of purchase of the pass.
6. The VIP Membership holder must be an adult with full legal capacity.
7. The VIP Membership is personal and can only be used by the authorized individual whose name is on the membership card.
8. Each time before using the membership, a valid photo ID must be presented at the reception desk.
9. The membership may be used during the operating hours of the relevant areas of the Przystań na Eisenberga facility for the duration of its validity.
10. The membership is valid for 30 days from the date of purchase.
11. The value of the membership cannot be exchanged for cash.
12. The membership is issued for a fixed period of 30 days. After this period, the membership expires.
13. The membership can be recharged, which will extend its validity according to the current Price List. This requires presenting the membership card in a condition that allows for continued use. The price, value, and validity of the membership are listed in the current Price List. Unused sauna minutes cannot be transferred to a new or recharged membership.
14. In the event of loss, theft, or damage to the membership card that renders it unusable, unused funds on the card will not be refunded. The fact of loss, destruction, or damage should be immediately reported to authorized personnel at Przystań na Eisenberga. Issuance of a new card requires payment of a fee of 22.00 PLN (in words: twenty-two PLN) to cover the cost of issuance. This fee is non-refundable.
15. Due to service quality, Przystań na Eisenberga reserves the right to limit the number of memberships sold and to halt further sales.
16. If the client recharges the membership within 14 days after its expiration, by purchasing a new membership according to the Price List, and thereby maintaining continuity, the activation fee of 22.00 PLN will be waived.
17. If the client does not recharge the membership within 14 days after its expiration, the activation fee of 22.00 PLN will be required upon subsequent purchase of a new membership, in addition to the membership fee as per the Price List.
18. Any interruption in membership continuity exceeding 14 days will result in the need to pay the activation fee of 22.00 PLN.
19. The 30-day VIP Membership may be suspended once during its active period for a fee of 30 PLN, for a minimum period of 7 days and a maximum of 14 days. The client bears a non-refundable fee for the suspension, which is a prerequisite for effective suspension. Suspension must be requested by sending an email to bok@przystannaeeisenberga.pl.
20. In cases where the membership holder is unable to use the services due to objective reasons, the service may be frozen until the cessation of the Force Majeure event, thus extending the membership by the period of suspension. Force Majeure is defined as events beyond the control of Przystań na Eisenberga that could not be foreseen and that disrupt or prevent the use of the membership.
21. Purchasing a membership implies that the client has read and accepted these Terms and Conditions. These Terms and Conditions apply to all VIP Membership holders. Purchasing a membership signifies acceptance of all applicable regulations within the Przystań na Eisenberga facility.
22. Any amendments to these Terms and Conditions must be made in writing and communicated to clients via the website and through public display.
23. In the event of changes to the Terms and Conditions, the client has the right to terminate the agreement, effective upon the expiration of the current membership period, by submitting a written or emailed declaration of intent, citing the change in the Terms as the reason for termination.
24. The client has 14 days to submit a declaration of intent to terminate the agreement following notification of changes to the Terms. Failure to submit a declaration within this timeframe will be interpreted as acceptance of the changes.
25. Przystań na Eisenberga reserves the right to modify the Price List and the scope of services. These changes do not constitute a modification of the Agreement or the Terms and Conditions.
